5. Due acknowledgement must be clearly stated upon the use of an item(s) from The Clark County Historical Museum and the legal holder of the copyright. Acknowledgement must be given even if the use of the item(s) is only in reference. 6. The borrower/purchaser must not allow any public or private agency to reproduce, in any form, any item(s) borrowed/purchased from The Clark County Historical Museum.
7. The borrower/purchaser agrees to give, free of charge, one copy of his/her publication, documentary or work to The Clark County Historical Museum.
8. Any deviations and/or amendments to this agreement should be attached to this agreement and signed by the borrower and The Clark County Historical Museum.
